THE TIMETABLE FOR THE BACHELOR'S AND DISSERTATION EXAMINATIONS (FOR THE UNIVERSITY STUDIES OFFERED JOINTLY AT BACHELOR'S AND MASTER'S LEVEL), RELATED TO THE ACADEMIC YEAR 2024-2025

Art. 1. The Bachelor's and Dissertation examinations shall be organised by the University of Medicine and Pharmacy "Victor Babeș" of Timișoara (UMFVBT) in the following sessions, under the same conditions, as follows:

- a) **Session I:** in **September 2025**, for **all undergraduate degree** programmes in the faculties of UMFVBT, undergraduate degree cycle and undergraduate degree offered in combined undergraduate and master degree;
- b) **the second session**, with the maintenance of the commissions established for the first session of the final exam: in **February 2026**, for **all the** undergraduate degree programs of the UMFVBT faculties, the undergraduate degree cycle and the undergraduate degree offered in combined bachelor and master.

Art. 2. The timetable for the licensing/dissertation examination is as follows:

a) in September 2025:

- **09.09.2025, 10 a.m.⁰⁰ - written test** (for all study programmes);
- **10.09.2025** - submitting and resolving any appeals to the written test; submitting appeals, at the university registry or by online transmission, to the faculty dean's e-mail address, can be done until 12:00 p.m.;
- **11.09.2025 - practical test** (for the study programmes of the Faculties of Dentistry and Pharmacy, respectively for the undergraduate degree programme Balneophysiokinetotherapy);
- **11-12.09.2025 - undergraduate/dissertation:** for **all** study programs within the Faculty of Medicine for which the practical test is not provided;
- **12.09.2025 - undergraduate/dissertation:** for study programs within the Faculties of Dentistry and Pharmacy, respectively for the undergraduate study program Balneophysiokinetotherapy and recovery, for which the practical test is provided

b) in February 2026:

- **03.02.2026, 10.00 a.m. - written test** (for all study programmes);
- **05.02.2026 - practical test** (for the study programmes of the Faculties of Dentistry and Pharmacy, respectively for the undergraduate degree programme Balneophysiokinetotherapy);
- **06.02.2026 - undergraduate/dissertation** (for **all** degree programmes).

Art. 3. The registration of the candidates for the Bachelor/Dissertation exam is done individually, at the dean's offices of the faculties, as follows:

- **until 25.07.2025**, for the **September session** of the final exam;
- **until 09.01.2026**, for the **February session** of the final exam.

Art. 4. The submission of undergraduate/dissertation papers to be checked with the anti-plagiarism software used by the University will be done no later than **22.07.2025**.

Art. 5. The technical briefing attended by the members of the licensing/dissertation commissions, together with the room managers, supervisors and operators, is organized by the central licensing/dissertation commission **in the week prior to the written exam of the first session of the final examination**, in the Aula Magna of the university (or online, link sent by e-mail, in justified cases).
